

Different Cats, Different Taxes


Income tax is usually what everyone is talking about The more \$ you make the higher % of each dollar you pay toward taxes.

Dollars \$0 - \$12,000 = 0% Income tax= Standard Deduction

- Dollars \$0 \$9,525 of taxable income=10% taxed
- \circ Dollars \$9,525 \$38,700 = 12% taxed
- \circ Dollars \$38,700 \$82,500 = 22% taxed
- **Etc....**







Self-Employment Tax = Social Programs

15% of All Your Profit for Social Security and Medicare

Keeping Track of Expenses

Keep Receipts in the Tax Categories as the year goes.

Keep a calendar of activities to show time spent.

You have a handout with all the tax categories and examples of what goes where.

Any system you actually use is a "Good System". Ex: The Envelope System, Mint.com, Outright.com, Quickbooks, spreadsheets.





Step 1: Write each tax category that you're likely to use. One category per envelope.



Step 2: Think, "is this purchase related to my business?" If YES...



Step 3: Put receipt in wallet. When wallet gets full...



Step 4: Put receipt in envelope.

Alternately: Buy something online, write on a scrap of paper, put paper in the envelope.
